鄭慕智律師是胡百全律師事務所首席合夥人,同時身兼多間香港上市公司之獨立非執行董事職務。 除香港特別行政區外,鄭律師亦擁有英格蘭、澳洲維多利亞省及新加坡的律師執業資格。鄭律師以訴訟 律師開始其律師事業,隨後拓寬至知識產權方面,近二十年來,鄭律師執業範圍主要集中在商業及金融 管治,特別是資本市場及監管法規方面。

鄭律師一直積極參與社會及教會服務,目前,彼擔任博彩及獎券事務委員會主席及香港交易及結算 所有限公司董事。鄭律師曾任香港交易及結算所有限公司上市委員會成員、副主席與主席,現為香港交 易及結算所有限公司董事。另外,鄭律師亦為財務匯報局成員、策略發展委員會委員、航空發展諮詢 委員會委員。鄭律師于一九九一年至一九九五年期間出任香港立法會議員。鄭律師並為香港董事學會 及香港歌劇院創會主席。鄭律師亦為香港聖公會法律顧問,更為扶輪社積極會員,曾於一九九三年至 一九九四年期間擔任國際扶輪3450地區總監。

Moses CHENG is the Senior Partner of Messrs. P. C. Woo & Co., a firm of solicitors, and also serves as an independent non-executive director of a number of companies whose shares are listed on the Stock Exchange of Hong Kong. Besides Hong Kong, he is also admitted to practise as a solicitor in England and Wales, State of Victoria, Australia and Singapore. He started his legal practice as a litigation lawyer. Then he switched to intellectual property and for the past 20 years his practice is mostly in the field of commercial and corporate work specializing in fund raising in the capital market and regulatory compliance.

At the moment, Mr CHENG is the Chairman of the Betting and Lotteries Commission and a director of Hong Kong Exchanges and Clearing Limited. Besides, he is a Member of the Financial Reporting Council, Commission on Strategic Development and Aviation Development Advisory Committee. Between 1991-95 he was appointed and served as a member of the Legislative Council of Hong Kong. Mr CHENG is also the Founder Chairman of The Hong Kong Institute of Directors and Opera Hong Kong. Mr CHENG serves as the Chancellor of the Hong Kong Anglican Church. Mr CHENG is also an active Rotarian having served as the District Governor of Rotary International District 3450 during 1993-94.
